2026 Election Judge Training

Regular Election Judges are required to complete a two-hour online training session. Only judges who will be serving as a Head Judge need to complete an additional hour of training. All training is coordinated through the Sherburne County Auditor/Treasurer's Office. Sherburne County hasn't provided the website link for the 2026 training. This information will be sent out to Election Judges when it becomes available, generally in May or June of the election year.
